Under orders dated 01.11.2023 of Hon'ble the Chief Justice, the recommendations of the Hon'ble Committee for monitoring the implementation of the resolutions passed in the Chief Justices Conferences, vide its meeting dated 27.09.2016 is once again forwarded to your goodself with a request to comply with the time-limit prescribed for sending the data with regard to pendency/arrears of the cases pertaining to district courts for submitting it to the Hon'ble Supreme Court of India by 10<sup>th</sup> of every month, the deadline fixed by the Apex Court.

The recommendations of the Hon'ble Committee are as under:-

- All the Judicial Officers will submit requisite data/information by 1<sup>st</sup> of every month to their concerned District & Sessions Judge.
- All the District & Sessions Judges will send the requisite data/information pertaining to their respective District (s) to the District & Sessions Judge (HQs) by 3<sup>rd</sup> of every month.

- District & Sessions Judge (HQs) will send the requisite data/information to this Court by 5<sup>th</sup> of every month and in case 5<sup>th</sup> happens to be a holiday, by 6<sup>th</sup> without fail.
- The data/information once sent to this Court will not be allowed to be changed either by District & Sessions Judge (HQs) or other District & Sessions Judges on any ground whatsoever.
- In case of non-compliance by any quarter, strict action will be liable to be taken.
- The Registry of this Court is directed to convey the above directions to all the District & Sessions Judges for strict compliance thereof. District & Session Judges, other than District & Sessions Judge (HQs), be also informed that they all are expected to give full co-operation to the District & Sessions Judge (HQs) to enable him not only to send the correct and complete data/information to this Court, but also to comply with the time-limit prescribed therefor.
