No. and in his absence,

before the 1st Link Judicial Officer of that serial number and so on and so forth. In case of unavailability of all the three Ld. Judicial Officer mentioned against police stations at Sl. No. 8, the bail applications shall be placed before the Judicial Officer mentioned at Sl. No. 1 and so on and so forth.

It is made clear that no additional P.A./Sr. PA. will be provided for bail applications.
