**Note:**

1. During the period from 01.06.24 to 07.06.24, the available Judicial Officers will also look after the bail work, civil work and administrative work already assigned, in addition to their own court work.
2. The undersigned shall be available w.e.f. 01.06.2024 to 07.06.2024 to look after the court work as well as for the administrative work and the period other than the dates as mentioned above shall be the period of Special Casual Leave of the undersigned.
3. In absence of the undersigned, the senior most Judicial Officer available in the district on the particular working day, shall act as the Officiating Principal District & Sessions Judge and shall look after the Administrative work of the North-West District. Any correspondence with the Hon'ble High Court of Delhi, New Delhi, shall be made with prior telephonic concurrence of the undersigned.
4. The Courts shall permit hybrid/video conferencing hearing, as per VC guidelines issued by Hon'ble High Court of Delhi.
5. The Judicial Officers shall be assisted by their own court staff.
6. The Judicial Officers deputed for any particular day shall be act as link of each other.
7. The office of the court will remain open daily from 10.00 am to 05.00 pm except on Second Saturday, Sunday and other holiday, if any.
8. The Judicial Officers so detained during Special Casual Leave(s) shall be entitled to avail compensatory leave as per rules for duty actually performed by them.
9. The remand and other Misc. Work pertaining to POCSO Act, NDPS Act, SC & ST Act & any other Special Act shall be dealt with exclusively by Ld. Vacation Judge/ASJ detained on the day mentioned against their names.
