A meeting of the Committee in respect of aforesaid agenda was held today i.e. 05.06.2024 at 03.30 PM in the supervision of Ld. Chairman, Election Committee, in his chamber at Room No. 408, Rohini Court Complex, Delhi.

One of the Advocate/Member Sh. Davinder Pratap Singh, is not present today. He has been telephonically informed by the Nodal Officer, however, he is reported to be out of station. He has informed that he will be available from 01.07.2024 onwards.

Nodal Officer has put up before the Committee, the order dated 28.05.2024 passed by Hon'ble High Court of Delhi in ***W.P. (C) no. 10363 /2021 in case titled as Lalit Sharma & Ors. v. Union of India & Ors.***

Order perused by the Committee, vide which has been reiterated as follows :

"....After some hearing, it transpires that there are more than 1.25 to 1.5 Lakh advocates registered with various Bar Associations of Delhi and capturing of biometric of these advocates would require considerable time and the process may not be completed within the timeline fixed by this Court in accordance with the Judgment dated 19th March, 2024.

9. Consequently, the present application is allowed and the direction to capture the biometric of the advocates/ registered clerks for the issuance of proximity/ identity cards in terms of judgment dated 19th March, 2024 is dispensed with. The application is accordingly disposed of....."

The order has been perused.


