**AGENDA:** To discuss about the further course of action with regard to the forthcoming Elections of RCBA in terms of the judgment passed by Hon'ble High Court of Delhi dated 19.03.2024.

In the previous meeting, a query was raised by Sh. Aseem Bhardwaj Member that whether more than one Advocate / assisting counsel whose names is reflected in a particular ordersheet can claim the right of 'bonafide advocate' on the basis of the presence so recorded in the said order sheet.

Sh. Davinder Pratap Singh, Member has submitted that he has gone through the judgment passed by Hon'ble High Court and has not find any substance in the query so raised in the last meeting.

This committee is of the unanimous view that as per the judgment passed by Hon'ble High Court in **WP(C) no. 10363/2021** titled as **Lalit Sharma v. Union of India & Ors.**, there is no bar on the Advocates claiming the right of 'bonafide advocate' on the basis of the presence so recorded in the order sheet where name of one Advocate and assisting counsel of the same firm reflects in the same order sheet.



District & Sessions Judge, North West, Rohini, Delhi**. Sh. Karan Bhardwaj, has also sent an email dated 04.07.2024 and has informed that the above said petition has been withdrawn on 04.07.2024, however, the order has not been uploaded in the Website till date. The Nodal Officer is directed to get the copy of the said order on record, as when the same is uploaded in the Website.




The Election Committee shall take up the further course of action on the next meeting which is to be held on **18.07.2024 at 03.00 PM** in the chamber of Id. Chairman.
