It has also been informed that the list from Bar Council of Delhi, of the members whose licenses have been suspended or whose degrees have been found to be fake, or the Advocates who have sought transfer from BCD to other States, and the candidates who have not cleared their AIB exam, has been received in excel format.

It has been proposed by the Members that information may be sought from BCD Delhi in respect of the following points :

- a) *Criteria for exemption from AIB examination.*
- b) *List of exempted members, if any.*
- c) *To clarify, if a member has completed his LLB on or before 2011, and had registered in BCD after 2011, whether he will be exempted from AIBE examination or not.*

In view thereof, it has unanimously decided that a letter be sent to BCD, in respect of the aforementioned information.


A letter be also issued to the Hony. Secretary, RCBA with a request to get his digital signature key for issuance of identity card of the RCBA members.
