timely elections in terms of the mandate of the judgment judgment WP (C) 10363/2021 titled as Lalit Sharma & Ors. v. Union of India & Ors. It has also been requested to appoint the Election Commission for managing and conducting RCBA Elections on time and to initiate the process of accepting nominations.

The Committee has gone through the said communication.

The Committee is well aware about the time frame given by the Hon'ble High Court of Delhi in the above said judgment, however, keeping in view the large number of objections and detailed scrutiny of the declarations forms, the said deadline could not be met, for the reasons beyond the scope of this Committee. However, it is the endavour of the Committee to get the voters list published as soon as possible, complete in all respects.

A request has also been made to this committee, to appoint the Election Commission for managing and conducting RCBA election and to initiate the process of accepting nominations, however, it is clarified that the appointment of Election Commission is beyond the scope of this Committee.

It has been reported by the Nodal Officer, that there are several Members who have filled in duplicate declaration forms and have also moved application for withdrawal of one of their declaration form.

It has also been Reported by the Nodal Officer that there are some applications which are filed by Members, who wish to withdraw their declaration forms on different grounds. The Committee has gone through the said forms and allowed the Members to withdraw their declaration forms, as prayed, as per the list **Annexure X**.

The Election Committee shall take up the further course of action on the next meeting on dated already fixed i.e. 20.09.2024 at 04.00 PM in the chamber of ld. Chairman.
