Necessary link for applying the proximity card has already been provided in the website of Rohini Courts. The last date, as per the MOM dated 03.09.2024 of the Hon'ble Court of Delhi, for applying the proximity card is 25.09.2024. It has also been mentioned in the said MoM that: "...casting of votes in the elections of the respective Bar Associations shall be permitted only to the holder of proximity cards...."

An application dated 18.09.2024 has been received from Ms. Deepmala, Advocate Enrl. no. D/2557/2008, RCBA Membership no. D-996, requesting to withdraw her declaration form.

Another application dated 19.09.2024 has been received from Sh. Badal Dwivedi, Advocate Enrl. no. D/4564/2018, RCBA Membership no. B-624, requesting to withdraw his declaration form as he wish to cast his vote in High Court Bar Association.

Committee has gone through the said applications.

This Committee has unanimously resolved that in view of the reasons mentioned in the application, the application filed by Ms. Deepmala, Advocate and Sh. Badal Dwivedi, Advocate be allowed and their application forms be treated as withdrawn.

It has been reported by the Nodal Officer, that there are 98 members whose declaration forms falls in the category of "INTERPOLATION IN ORDER SHEET", and out of them some Members have already moved applications seeking withdrawal of their declaration forms, while some of the Members have filed fresh order sheets along with objection removal form, so that their declaration form with interpolated ordersheets may be considered.

The Committee has gone through the said issue.

The Committee has unanimously resolved that all the 98 declaration forms falling in the category of "INTERPOLATION IN ORDER SHEETS" as mentioned in the tentative voters list, stands rejected, and it is further made clear that no further applications/grievances in this respect would be entertained for the forthcoming elections of RCBA.

It is submitted by the Nodal Officer that, as per the list of objections with respect to dues paid by the members from their own account or others account, the scrutiny is complete. However, there are certain declaration forms, wherein the members have claimed that the payments of dues have been paid from their own account, however, they have not filed the relevant documents showing that the said amount has been paid by them or their immediate family member(s) through their own bank accounts. The list of such members, wherein the amount has been claimed to be paid from their own bank account or their immediate family member(s) is annexed herewith as **Annexure Y**.

The Committee has gone through the said issue.

As per the mandate of the judgment WP (C) 10363/2021 titled as Lalit Sharma & Ors. v. Union of India & Ors., the members have to pay the subscription from their own account.

However, this Committee, vide minutes of meeting dated 28.08.2024, has already given relaxation to the effect that the declaration forms, where dues/subscription is paid by immediate family member/blood relation shall be considered in the category of "eligible voters" subject to their furnishing proper documents in this regard.

The Committee is of the unanimous view that an opportunity should be given to the members who have paid the subscription dues from their own bank account(s) or from the account of their immediate blood relatives.

The list **Annexure Y**, be published in the Rohini court website and notice board of RCBA and be also sent to The President/Hony. Secretary, RCBA for circulation in the BAR.

The name of the members, as mentioned in the said list **Annexure Y** are required to furnish the complete bank details showing the payment of the subscription/dues paid from their own bank account or from the account of their immediate blood relatives (with ID proof showing relationship) within three days from today i.e. till 26.09.2024. **Such documents shall be submitted in Room no. 503 from 11.00 AM to 04.00 PM.**
