

Sub: Directions for private foreign visits.

Sir/Madam,

In continuation to this Court's letter No. 2634-2647/DHC/Gaz.II-A/G-10/2024 dated 26.04.2024 on the above subject (copy enclosed), I am directed to inform you that the Hon'ble Welfare Committee of this Court in its meeting held on 05.11.2024 has observed that in cases where permission to visit abroad is granted, despite the directions to submit the details of expenditures within one month of completion of such visit, most of the Judicial Officers furnish the details of expenditures very late and that too after reminder/s issued by this Court.

2. The Committee has also observed that the number of Judicial Officers going on foreign travel for a period which also consists of working days, is on increase which puts in unnecessary burden on the functioning of other Courts, particularly the Link Courts.

- 3. Therefore, in continuation to the earlier directions, on the recommendation of the Hon'ble Welfare Committee, Hon'be the Chief Justice has been pleased to further direct that:
 - (i) if any officer does not submit the expenditure details within stipulated 30 days time of the return from abroad, an adverse inference will be drawn by this Court.
 - (ii) if any officer does not perform the foreign visit, after seeking permission from this Court, he/she will also submit an intimation in this regard within 30 days from the expiry of period for which permission was granted.
 - (iii) while forwarding the applications of Judicial Officers seeking permission to visit abroad in any month, the Pr. District & Sessions Judge/Controlling Office will indicate the names of those Judicial Officers whose applications for abroad visit for the same month, have already been forwarded by them. It is also to be indicated in the forwarding letter that in case the permission to visit abroad is granted to the officer, it will not cause any hardship in the distribution of his judicial work and no Link Court will be overburdened.

Sub: Directions for private foreign visits.

Sir/Madam,

I am directed to inform you that on the recommendations of the Hon'ble Committee to consider matters relating to welfare of Judicial Officers, Hon'ble the Acting Chief Justice has directed that the judicial officers holding Courts should not be encouraged to travel abroad on personal trips during Court working days by availing leaves, unless there are justifiable reasons for the same.

In case there are justifiable reasons the applications of judicial officers for private foreign visits involving not more than three Court working days can be considered by this Court, on a case to case basis.

The Principal District & Sessions Judge/the Controlling Authority of the concerned judicial officers shall not forward to this Court/reject the applications of judicial officers for private foreign visits, where the period of such private foreign visit includes more than three Court working days, unless such private foreign visit is necessitated on account of justifiable reasons other than tourism/leisure.
