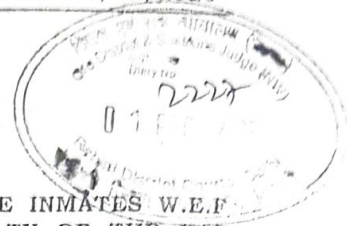

District/States and UTs during the period from 01.02.2025 to 06.02.2025 may kindly be adjourned from hearing/peshi due to non availability of Force and Next date of Hearing/peshi may kindly be intimated to all concerned accordingly. It is also to inform that during the period from 01.02.2025 to 06.02.2025 Nyayik Abhiraksha Vanhini DAP will also not be in a position to provide escort guard in respect of UTP's required to be produced in the Hon'ble Court of Delhi and out of Deli due to Forthcoming general election of Delhi Legislative Assembly" (Copy Enclosed)

In view of above submission this Hon'ble Court is humbly informed that this office is not able to produce the inmates before the concerned Hon'ble Courts from 01.02.2025 to 06.02.2025.

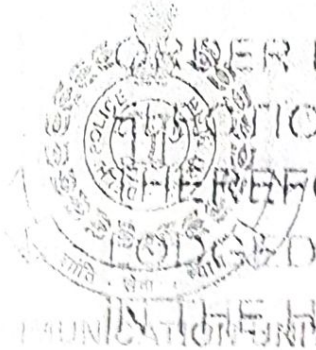
