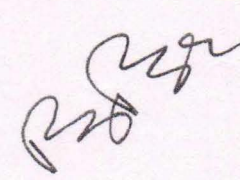

In super-session of earlier order no. 33809-868/Bail section/RC/NW/2026 dated 03.08.2026 and in exercise of power conferred under section 8(8) of the Bhartiya Nagrik Suraksha Sanhita, 2023, the following Ld. Additional Sessions Judge(s), mentioned in the column no. 03, are hereby authorized to dispose of bail applications pertaining to the police stations of North-West District, as per the direction of the Hon'ble Principal District & Sessions Judge, North -West District, Rohini court, mentioned in the column no. 02, **with immediate effect** till further orders :-

Note:-

1. It is hereby ordered that Bail Applications presently pending before the Hon'ble Court being presided over by Sh Sanjay Sharma-II, Ld ASJ, Spl Judge ,NDPS, North-West District, Rohini, (except those pertaining to the NDPS Act) shall stand withdrawn with immediate effect and assignd to the Hon'ble Courts as mentioned above.
 2. If the Ld. Judicial Officer mentioned in the column no. 3 happens to be on leave or not available for any reason, then the Reader of the concerned Court shall place the bail applications before the 1st Link Ld. Judicial Officer mentioned in column no. 4 for disposal as per law, and so on.2. If all the three Ld. Judicial Officers mentioned in column nos. 3, 4, & 5 against Police Stations appearing from Sl. no.1 to 4 happen to be on leave or not available for any reason, then the bail applications of the concerned Police Stations shall be placed for disposal as per law, before the Ld. Judicial Officer mentioned in column no. 3 immediately below that Sl. No. and in his absence, before the 1st Ld. Link Judicial Officer of that serial number and so on and so forth. In case of unavailability of all the three Ld. Judicial Officer mentioned against police stations at Sl.No. 5, the bail applications shall be placed before the Ld. Judicial Officer mentioned at Sl. No. 1 and so on and so forth.

3. That once a bail application pertaining to a Police Station assigned to a particular Hon'ble Court under the roster is received by that Court, the said application shall be decided exclusively by that court. This shall apply not withstanding any subsequent change or modification in the roster. The purpose of this addition is to avoid transfer of newly instituted or part heard bail applications already assigned to a Court for speedy disposal in view of the urgent nature of the application.
4. Bail applications pertaining to designated courts shall be dealt with by the concerned Judicial Officer as per the regular roster.
5. The link roster for the bail matters before the Hon'ble ASJ (Spl.FTC) North-West, shall remain the same as specific in this Bail Roster.
6. All concerned Readers shall return the bail record to the Bail Section:
 - (a) After disposal of the bail application, and
 - (b) upon any change in the Bail Roster.
7. It is made clear that no additional P.A./Sr. PA. will be provided for bail applications.
