

## Action taken against responses made by candidates in reject list

As per the advertisement No. DSC(BDL)/RC-01/2023 Dated Bomdila, the 29<sup>th</sup> April 2024 for the recruitment of various post under the jurisdiction of the District & Sessions Court, Bomdila (Tawang, West Kameng, East Kameng & Pakke Kesang), Arunachal Pradesh, the deadline for online form fillup was till 29<sup>th</sup> May 2024 till 4 p.m. Further, after the deadline and scrutiny of the applications submitted by the candidates, a rejected list of candidates was prepared, considering payment/transaction and age as the criteria. The list was published in the website of District and Sessions Court, Bomdila as well as mail was sent to the respective candidates whose names were in the rejected list on 04<sup>th</sup> June' 2024. The candidates whose name were in the said list were asked to file application to claim/ object the issues for which their names were in the said list till 4 p.m. of 11<sup>th</sup> June' 2024 via email to [recruitment.dscbomdila@gmail.com](mailto:recruitment.dscbomdila@gmail.com). Accordingly, several emails regarding claim/ objection/ clarification were received, however, after scrutiny/ thorough checking, the following 13 (thirteen) nos. candidates were withdrawn from the rejected list:

- ii. **Based on category:** Candidates who have filled the recruitment application form under "ST" category and are claiming to be in "APST" category in the response mail towards rejected list stands to be rejected.
