Therefore the Chief Judicial Magistrate, Sircilla has been pleased to pass the following:

ORDER

In exercise of powers conferred by Section 14 (1) and Section 15 (2) of the Code of Criminal Procedure, 1973, the Judicial First Class Magistrate mentioned in Column No.3 is hereby empowered to record the Sec.164 Cr.P.C statements of witness in respect of POCSO Act cases and also to conduct Test Identification Parades in respect of accused or case properties and also to record the Sec.164 Cr.P.C statements of witnesses relating to police stations within the territorial jurisdiction exercised by the Judicial First Class Magistrates mentioned under column No.2 in the tabular given below.
