



TERMS & CONDITIONS

1. The hardware spare items which are going to repaired/replaced must be under warranty as per norms.
2. The work of repairing shall be performed in Computer Center, District Court, Lucknow on working days between **10.00 a.m. to 4.00 p.m.**
3. The vendor must ensure that the engineers working on behalf of the vendor must be having all the tools etc. for repairing.
4. The payment of the work shall only be made after satisfactory report of the Computer Technical Staff.
5. The mode of payment shall only be made through District Treassaury by online mode after the due approval of the Hon'ble District Judge, Lucknow.
6. After repairing if any problem reoccurs in the defective Printers the vendor shall send the engineer for the same for checkup till the warranty of the replaced part exists.
7. The work of repairing must be completed from the date issuance of work order.
8. The Purchasing, Committee, District Court, Lucknow will have the rights to cancel the work Order fully or partially at any time.
