3. The persons who are of sound health and active habits alone will be considered.
4. The persons with proven record of ability, good performance, and integrity alone will be considered.
5. The persons who have received any punishment for any misconduct in disciplinary proceedings while in service are not eligible for consideration.
6. The service of the re-employed employees are liable to be terminated at any point of time without assigning any reasons and without any notice and the appointment is purely temporary and on contract basis.
7. Persons selected have to produce Fitness Certificate and enter into an agreement/contract with the District Judge, Mahabubnagar on such terms and conditions as the appointing authority deems fit, proper and necessary regarding the conditions of appointment and service and on all other required particulars.
8. Tenure of appointment will be from the date of joining until the need for appointment ceases.
