### ELIGIBILITY FOR THE POST OF EDITOR:

The applicant for the above said post of Editor shall be,

- a) Retired Super Time Scale District Judges of the Telangana State Judicial Service. If no suitable Retired District Judge in the Super Time Scale is available for appointment, the post shall be filled with Selection Grade Retired District Judge, and if no suitable Selection Grade Retired District Judge is available, it shall be filled with District Judge, retired with entry level pay scale. The candidates having proficiency /command over Telugu language or having Telugu Literature in Graduation or Post Graduation shall be given preference, while making appointment to the post.
- b) The age of the applying retired Judicial Officer shall not exceed 70 years as on the date of this notification.

# ELIGIBILITY FOR THE POST OF DEPUTY EDITOR:

The applicant for the above said post of Deputy Editor shall be,

c) Retired Selection Grade District Judge of the Telangana State Judicial Service.

- d) If no suitable Selection Grade Retired District Judge is available, the post shall be filled with <u>District Judge</u>, retired with entry level pay scale.
- e) The candidates having proficiency / command over Telugu language or having Telugu Literature in Graduation or Post Graduation shall be given preference while making appointment to the post.

f) The age of the applying retired Judicial Officer shall not exceed 70 years as on the date of this notification.

# ELIGIBILITY FOR THE POST OF REPORTER:

The applicant for the above said post of Reporter shall be,

- g) Retired Civil Judge (Senior Division) of the Telangana State Judicial Service. The candidates having proficiency /command over Telugu language or having Telugu Literature in Graduation or Post Graduation shall be given preference, while making appointment to the post.
- h) The age of the applying retired Judicial Officer shall not exceed 70 years as on the date of this notification.

# METHOD OF RECRUITMENT FOR THE POSTS OF EDITOR, DEPUTY EDITOR AND REPORTER:

Selection shall be based only on Articles and Journals published/ submitted by the applicants, and considering the candidate's proficiency both in English and Telugu languages. The Interactive Sessions with the eligible and suitable candidates, will be conducted after inviting applications from the interested candidates.

# GENERAL INSTRUCTIONS TO THE APPLICANTS FOR THE POSTS OF EDITOR, DEPUTY EDITOR AND REPORTER.

- a) The appointment to the posts shall be initially for a period of 2 years or till attaining the age of 70 years, whichever is earlier.
- b) Monthly remuneration shall be last drawn pay (Basic+DA) Pension, as per G.O.Ms.No.127, dated 23-09-2023.

- c) Upon successful and satisfactory completion of two years service in the post of Deputy Editor, such Deputy Editor shall be given preference in filling the vacancy for the post of Editor.
- d) No retired District Judge or retired Civil Judge (Senior Division) who was awarded the major punishment for any misconduct in discharge of his/her duties as Judicial Officer or pending any departmental enquiry against him/her, shall be eligible for appointment to the posts of Editor, Deputy Editor or Reporter in the I.L.R. and Translation Wing of the High Court for the State of Telangana.
