- 2) If the Candidates marked with (*) or (#) or both marks against his/her Name in the above Select List are appointed, then the appointment of the said Candidates shall be subject to the following conditions :-
 - (a) Appointment of candidates for the post of Stenographer (Grade-3) will be on ad-hoc basis.
 - (b) The candidates marked with (*) mark against his/her Name in the above Select List will have to pass the Marathi Shorthand Test afresh within a Period of one year from the date of their respective appointment.
 - (c) The candidates marked with (#) mark against his/her Name in the above Select List will have to pass the English Shorthand Test afresh within a Period of one year from the date of their respective appointment.
 - (d) The candidates marked with (*) and (#) mark against his/her Name in the above Select List will have to pass the both test i.e. Marathi Shorthand and English Shorthand Test afresh within a Period of one year from the date of their respective appointment.
 - (e) On appointment, the candidates marked with (*) and (#) mark against his/her Name, he/she shall have to give an undertaking to the effect that his/her appointment is on ad-hoc basis and he/she will be discharged from the service if he/she fails to clear the requisite tests as mentioned in above Conditions (a) to (d) within a period of one year from the date of his/her appointment.
