ORDER


Pursuant to directions of Hon'ble High Court of Delhi vide order No. 570-600/RG/DHC/2021 dated 19.08.2021 and in continuation of this office's earlier order No. Admn./2021/SED/10088-10170 dated, New Delhi the 13.08.2021, all the Judicial Officers may call the staff w.e.f 24.08.2021 as per the requirement of the Courts. Further, all the Branch In-charges are directed to prepare a roster to ensure that officials in their respective Branches are reporting for duty on proportionate rotational basis so as to ensure that their footfall is reduced to 50%. They are also directed to endorse a copy of the roster to the Branch In-charge, Administration Branch, South East District, Saket Courts Complex, New Delhi.

All the officials are directed to perform their duties subject to strict observance of the conditions qua Covid-19 prevention guidelines of social distancing and Aarogya Setu App etc.

NOTE :

1. All those officials who are not required to report for duty on any given day, would not leave the station under any circumstances without the approval of competent authority. They would always be available on call and would be deemed to be on duty, their concerned Presiding Officers/Branch Incharges may call upon them to report for duty as and when required.
2. If any official does not report for duty on any given day despite the direction of his/ her Concerned Presiding Officer/Branch Incharge, then he/she has to submit the leave for that period mentioning the reason for the same.
3. All the Branch Incharges are responsible for the smooth functioning of their branches.

Non compliance of all the above instructions will be viewed seriously.


