In case of any urgency, District & Sessions Judge may call upon them to report back for duty immediately. In view of the non compliance the necessary consequences shall follow.

All the Court rooms and other parts of the Court Complex would remain closed except Room for use of Ld. Duty M.M. Filing of fresh matters of extreme urgency and urgent in nature shall be filed as per the advisory given in the Office Order No. Judl./Circular/ F.43/SE/Saket/2020/4628-4685 dated 22.04.2020.

The above directions shall come into force w.e.f 04.05.2020 and would remain in force till 17.05.2020.
