CIRCULAR

Pursuant to Order of Hon'ble High Court of Delhi bearing No. R-159/RG/DHC/2020 dated 02.05.2020 and in continuation of this Office Circular No. Admn./2020/SED/4588-4593 dated 15.04.2020, the functioning of the Courts of South-East District shall continue to remain suspended till 17.05.2020 on same terms. In view of the same, following directions are issued.

All the cases listed in the Courts of South-East District, Saket Courts Complex, New Delhi during the period from 04.05.2020 to 16.05.2020 shall stand adjourned *en bloc* as under:

Precedent may be given to the cases fixed in Orders. All hearings, as far as possible need to be conducted through Video Conferencing only. If Video Conferencing is not feasible, the crucial norms of social distancing be strictly adhered to during court room hearings.

All the staff officials who are not required to report for duty on any given day would not leave the station under any circumstances, and in case of any urgency, they would always be available on call and would be deemed to be on duty. In case of any urgency, District & Sessions Judge may call upon them to report back for duty immediately. In view of the non compliance the necessary consequences shall follow.

All the Court rooms and other parts of the Court Complex would remain closed except Room for use of Ld. Duty M.M. Filing of fresh matters of extreme urgency and urgent in nature shall be filed as per the advisory given in the Office Order No. Judl./Circular/F.43/SE/Saket/2020/4628-4685 dated 22.04.2020.

The above directions shall come into force w.e.f 04.05.2020 and would remain in force till 17.05.2020.
