- 2. The duties of Metropolitan Magistrate (Reliever) shall be assigned by the CMM (South East), Saket Courts.
- 3. Ms. Aishawarya Sharma shall look after the work of the court of Ms. Vasundhra Azad, MM-03
- 4. Session Judges on duly shall deal with the fresh bail applications as per bail roster issued vide this office order no. 59 dated 26.07.2021. Whenever bail roster Judicial Officer is on leave his work shall be looked after by the link judicial officer.
- 5. All the courts shall made endeavour to take up stay applications, bail applications and other miscellaneous urgent matters on physical days, wherever request to such effect is made.

The earlier direction issued by Hon'ble High Court of Delhi, New Delhi vide Office order No. 256/RG/DHC/2021 dated 08.04.2021 that no adverse orders shall be passed by the District Courts in Delhi in case of nonappearance of parties and/ or their counsel stands withdrawn w.e.f.

- 6. On physical hearing days, the Courts shall, wherever possible, permit hybrid/video conferencing hearing where a request to such effect is made by any of the parties and/ or their counsel.
- 7. During physical hearing, the courts exercising criminal jurisdiction, shall give top priority to those cases where the accused are in custody as well as to 5 years old cases. The courts, exercising civil jurisdiction, shall, on physical days, take up those matters which are more than 5 years old and/or those which are time-bound.
- 8. No person who is without a face mask or is suffering from any Covid-19 symptoms shall be allowed entry in the Court Complex. All persons visiting the Court Complex shall maintain physical/ social distancing and shall scrupulously comply with all the guidelines/ directions/ SOPs issued by the Court Administration/ other authorities.
- 9. In order to restrict the footfall, only those litigants shall be allowed entry into the Courtroom(s) whose appearance is recommended by their respective counsel or who are appearing in person or whose presence has been directed by the Court.
