CIRCULAR

Pursuant to Hon'ble Delhi High Court Order No. R-78-110/RG/DHC/2020 dated 15.04.2020 & No. R-7-39/RG/DHC/2020 dated 13.04.2020 and in continuation to this officer Circular No. Admn./2020/SED/4457-4462 dated 30.03.2020 the following directions are being issued for compliance by all the Judicial Officers and Officials of South-East District:

1. The functioning of all the Courts of the South-East District shall remain suspended till 03.05.2020.
2. All the matters listed in all the courts between 16.04.2020 and 02.05.2020 shall be taken up as under:

All the staff officials who are not required to report for duty on any given day would not leave the station under any circumstances, and in case of any urgency, they would always be available on call and would be deemed to be on duty. In case of any urgency, District & Sessions Judge may call upon them to report back for duty immediately.
4. The 'Lockdown/suspension of work' of Courts shall be deemed as "closure" within the meaning of the Explanation appended to Section 4 of the Limitation Act, 1963 and other enabling provisions of the Act and other Statutes, as may be applicable to Court proceedings.
5. All the Court rooms and other parts of the Court Complex would remain closed except Room for use of Ld. Duty M.M and Ms. Vinod Bala, Sr. Administrative Officer (Judicial), Ms. Usha Arora Link Administrative Officer (Judicial). Filing of fresh matter of extreme urgency before the Sr. Administrative Officer and her link shall be done between **10.00 A.M. to 04.00 P.M.**

The above directions shall come into force w.e.f 16.04.2020 and would remain in force till 03.05.2020.
