- 4. Each Branch/Cell shall have work allocated amongst the staff subject-wise, with arrangement for link Assistant (on account of absences of regular dealing hand), for which the OICs shall issue formal orders, in consultation with and under intimation to the undersigned.
- 5. The Officer(s)-in-Charge of the Administration Branches are hereby authorized to regulate and take appropriate decisions, as per rules, on the applications for leave of all members of categories of staff under their respective control.
- 6. Sh. Raj Kumar Chauhan, District Judge (Commercial), is hereby authorized to regulate and take appropriate decisions, on applications for leave of the officers of Delhi Higher Judicial Services and Delhi Judicial Service as per rules.
- 7. Sh. Sunil Samyal, Branch In-Charge, Judicial Branch, is hereby authorized to look after the work of process i.e. Service of summons upon Judicial Officers/ Officials. In the absence of Sh. Sunil Samyal, Branch In-Charge, Judicial Branch, Sh. Brijesh Kumar Sharma, Branch In-Charge, Adminstration Branch. South East District, Saket Courts, New Delhi.
