CIRCULAR

Pursuant to Order of Hon'ble High Court of Delhi bearing No. 26/DHC/2020, dated 30.07.2020, it is directed that Courts shall henceforth take up all the cases listed before them through videoconferencing. However, evidence shall be recorded only in ex-parte and uncontested matters where the same is required to be tendered by way of affidavit. The Judicial Officers shall be permitted to come to court for holding videoconferencing hearings from their respective chambers only when they do not have requisite technical infrastructure at their residences or where there is a breakdown of such infrastructure. Physical hearings shall be permitted in those matters only where a grave urgency is involved and hearing through videoconferencing is not feasible.

In view to facilitate the appearance of the Advocates/parties/others in their cases through videoconferencing, a link with name "LINK TO CONNECT IN COURT HEARINGS THROUGH VIDEO CONFERENCING" has been created on the website. The main purpose of this link is that the advocates/ parties/others may join the daily Court Proceedings through Video Conferencing by the given meeting URL which does not require any meeting Id or Password. After clicking, a list mentioning the name of Reader alongwith mobile no., email id and Court Meeting URL's of CISCO Software of each Court will be displayed. The advocate/parties/others have to click on the URL of that particular court in which they want to be appear for court hearings. In case if a meeting is being rescheduled or separately being set up, then a new link would be generated for which the Reader may be contacted by the mobile no. and email id provided in the said list.
