CIRCULAR

Pursuant to Order of Hon'ble High Court of Delhi bearing No. 1347/DHC/2020 dated 29.05.2020 and in continuation of this Office Circular No. Admn./2020/SED/5461-5466 dated 22.05.2020, the functioning of the Courts of South-East District shall continue to remain suspended till 14.06.2020 on same terms. In view of the same, following directions are issued.

All the cases listed in the Courts of South-East District, Saket Courts Complex, New Delhi during the period from 01.06.2020 to 12.06.2020 shall stand adjourned *en bloc* as under:

Besides above, all the courts shall also take up the matters ready for final arguments, while giving preference to more than 10 years old cases and cases where the accused is in Judicial Custody. MM (Mahila Courts) shall take up matters in which interim urgent relief has been sought under the Protection of Women from Domestic Violence Act, 1985. Rent Controllers/Addl. Rent Controller shall take up matters in which application seeking leave to contest/defend is pending disposal in the cases filed on the ground of bonafide requirement. All such matters shall be taken up through videoconferencing only. The counsel for both sides may be impressed upon to send brief written submissions through email.

The Judicial Officers are advised that no adverse order shall be passed without giving hearing through videoconferencing or without having written submissions from the concerned counsel. If any Judicial Officer wants to pronounce judgment in the physical presence of the parties, all the necessary precautions be taken to maintain social-distancing.

All the staff officials who are not required to report for duty on any given day would not leave the station under any circumstances, and in case of any urgency, they would always be available on call and would be deemed to be on duty. In case of any urgency, District & Sessions Judge may call upon them to report back for duty immediately. In view of the non compliance the necessary consequences shall follow.

All the Court rooms and other parts of the Court Complex would remain closed except Room for use of Ld. Duty M.M. Filing of fresh matters of extreme urgency and urgent in nature shall be filed as per the advisory given in the Office Order No. Judl./Circular/F.43/SE/Saket/2020/4628-4685 dated 22.04.2020.

The above directions shall come into force w.e.f. 01.06.2020 and would remain in force till 14.06.2020.
