1. This is 2nd meeting of the Election Committee. Committee has received a letter dated 01.10.2019 from Sh. Dhir Singh Kasana, Hony. Secretary, SBA wherein it has been advised to amend Annexure-A "Declaration Form" by adding one sentence i.e, 'I am hereby enclosing self attested copy of identity card of BCD/SBA". It is resolved by the members of the Committee that Declaration Form shall be accompanied with self-attested copy of identity card of BCD/SBA which is self explanatory and requires no amendment in the format of Annexure-A "Declaration Form" and it will delay the Election Process. Declaration forms and self attested copy of the ID of BCD/SBA alongwith the list of eligible voters be submitted by Saket Bar Association before the Committee in digitized format within one week.
2. It is informed by the Office that data has been received from the Hon'ble High Court of Delhi and other Court Complexes including, Tis Hazari, Patiala House Court, Dwarka and Karkardooma Courts. It is informed that a copy of final voter list received in digital format from Hon'ble High Court of Delhi with the request to return the same to the Hon'ble High Court of Delhi after the need is over.

The requisite information was also called from Supreme Court Bar Association, Tax Bar Association, National Green Tribunal Bar Association, Debts Recovery Tribunal Bar Association, Central Administrative Tribunals Bar Association and Armed Forces Tribunal Bar Association, but no information has been received from them till date.

4. It is resolved that request letter to the Ld. District & Sessions Judge, Rohini Courts Complex be sent for calling the record of last elections conducted by the Bar Association in their Complex in digital format by 24.10.2019 to enable the Committee to scrutinize the declarations filed by the members of SBA, let reminder be also sent to other Bars to provide the same within one week.
5. Committee has received a letter dated 13.09.2019 from Bar Council of Delhi regarding "Non-passing of All India Bar Examination (AIBE)".
6. It has been resolved by the Members of the Committee that the copy of the letter be sent to the Saket Bar Association to look into the matter at the time of submission of the said Declaration Forms.
7. The information with regard to the above be placed on all the notice boards of SBA through Caretaker and be also put on the website of District Court Saket, as it is informed that SBA has no website of their own. Minutes of this Meeting be also put on the Website of District Courts through computer branch to maintain transparency.
