This is in continuation of this office earlier directions, it has been observed that despite repeated

directions, some of the officials are not uploading Daily Orders / Miscellaneous Orders and Judgements

on regular basis.

It is impressed upon all the Ld. Judicial Officers of South District and South-East District to

direct their Sr. Personal Assistant / Personal Assistant to upload Daily Orders / Miscellaneous Orders

(except case related to matrimonial matters (Family Courts), Juvenile Justice Act, Official Secrets

Act, matters relating to Intelligence Agencies, matter relating to domestic violence and sexual offences

against women and children etc.) on daily basis in the CIS Data Base Server, without fail, so as to

avoid inconvenience to the Lawyers and Litigants,

Judgments be uploaded in the CIS Data Base Server at the earliest and in any case within 48

hours of pronouncement.

Further, in view of the recent directions vide Office Order no. 896/RG/DHC/2021 Dated

30.12.2021 from Hon'ble High Court of Delhi, wherein District Courts in Delhi shall hold court through

Virtual mode only till 15.01.2022, it is impressed upon all the Ld. Judicial Officers of South District and

South-East District to direct their Sr. Personal Assistant / Personal Assistant to upload Daily Orders /

Miscellaneous Orders (except exempted matter as mentioned above) on Daily basis on CIS Data Base

Server, without fail during this period and further also, whenever such type of arrangement is

necessitated, keeping in mind the Covid-19 Pandmic.

Further, Reader / Ahlmad of the Courts of South District and South-East District be directed to

keep the Data entry updation on CIS Server of their respective Court upto date, whether the Court is

functioning through Physical / virtual mode.

Any lapse on this score would invite disciplinary action against the erring official.

This issues with the approval of Ld. Officiating Principal District & Sessions Judge, South District and Ld. Principal District & Sessions Judge, South East District.
