






URGENT NOTICE

All Learned Advocates, Parties/Litigants are requested to kindly contact Copying Agency functional at Room No. 303, 3rd Floor, Rohini District Courts, Delhi and its Certified Application Counter functional at Ground Floor, Rohini District Courts, Delhi on any working day during working hours i.e. 10:30 AM to 01:00 PM & 02:00 PM to 03:30 PM to collect the certified copies prepared till 31.12.2021 which are lying ready for delivery pursuant to the application made during 01st July, 2021 to 31st December, 2021. It is notified for information of all concerned that if the said certified copies are not collected up to 08.07.2022, the said unclaimed copies would be destroyed, without any further notice and the amount so deposited by the applicants for such attested copies shall stand forfeited in view of "Rule 10 A added in Ch.5-B, Delhi High Court Rules & Orders Volume V, published in the Delhi Gazette on 01.09.2009" which explains "in case the attested copy is not collected within 120 Days from the date of its preparation, it will be destroyed and the amount deposited for such attested copy shall stand forfeited".
