Sub: e-Filing of Caveats in Delhi District Courts.

Respected Sir/Madam,

Reference is invited to the ibid subject. It is to inform your good self that the office has received order dated 02.06.2021 (Flag-A) passed by the Hon'ble High Court of Delhi in W.P.(C) 5746/2021 titled as Tarang Gupta Vs District & Sessions Judge (HQs), Tis Hazari Court with respect to e-filling of caveats. The directions given by Hon'ble High Court read as under:

"The Delhi District and Sessions Judge (Headquarters) shall ensure that in the future, no litigant or counsel is caused any inconvenience on this ground and henceforth, as long as the e-filing portal of the Delhi District Courts is functional, it will accept electronic filing of Caveats"".

However no such facility of online filing of caveats has yet been made available in the e-filing portal ofDelhi District Courts, by Hon'ble E- Committee Supreme Court ofIndia. Accordingly necessary steps are being taken by Centralized Computer Committee through Hon'ble High Court of Delhi to get the facility activated n the e-filing portal. However, till the time such a facility is made available by Hon'ble E- Committee somesteps have been taken by the office to comply with the aforesaid directions contained in order dated 02.06.2021 (Flag-A). Accordingly, considering the present scenario on account of Covid-19 pandemic, Ld. Principal District & Sessions Judge (HQ) has been pleased to approve that lawyers and litigants in the meantime be permitted to file caveats online on the email ids created (as given here under) for the various JudicialDistricts and thereafter such caveats may be downloaded by the respective filing counters and dealt with in the same way as caveats filed physically at the filing counters are dealt with.
