CIRCULAR

Sub. :- Preparation of Penal of Presenting Officers.

All the officials/staff members i.e. J.J.A./J.A./Sr.J.A./A.O.(J)/Sr.A.O.(J)/P.A./Sr.P.A. to send their willingness to work as Presenting Officer after the court hours, for presenting the case on behalf of the department in the departmental inquiries pending in this establishment.

As per the Office Memorandum No. 142/15/2010-AVD-I, Government of India, Ministry of Personnel, Public Grievances and Pensions (Department of Personnel & Training) dated 31.7.2012, the full amount of honorarium will be paid when the inquiry is completed within a period of six months. If, there is a delay in completion of the inquiry which is not due to non-cooperation of the charged official or due to stay order etc, the honorarium will be reduced by 50%.

The revised rates of honorarium payable in the cases of departmental inquiries/ proceedings will be regulated within the range of rates as indicated in the table below :-
