

Term and Conditions for Auction Of Four Photocopier Machines and Other Furniture Articles (as mentioned in the auction notice) to be held on Dated 25th July 2018 at 2.30 PM at Patiala House Courts, New Delhi

1. The bidders/ participants have to deposit Rs.10,000/- each as security amount with care Taking Branch, Patiala House Courts, New Delhi in order to participant in the bid on dated 25th July 2018 by 1.00 PM.
2. The Reserve price of four Photocopier Machines has been fixed Rs.16,000/-i.e. @ of Rs. 4000/- each.
3. The Reserve price of 05 Steel Almirahs, 15 Locks, 4 Heat Convector, 10 Steel Tables, One Vacuum Cleaners, 03 Tea Kettles, 05 Desert Cooler, 05 Water Jugs, 27 Wall Clock, 50 Chairs, Approx. 400-500 Kg Raddi (Waste Papers) has been fixed at Rs. 6000/- collectively.
