ORDER

Pursuant to the directions of Hon'ble High Court of Delhi Order No. 417/RG/DHC/2020 and in continuation of this office order No. Admn./2020/SED/7937-8013, Dated 15.08.2020, it is hereby directed that all the Judicial Officers who hold the Courts physically as per the duty roaster or virtually through videoconferencing w.e.f 01.09.2020 to 30.09.2020, shall ensure that they may call the 1/4th or required staff of their Courts for performing duties.

Further, all the Branch In-charges are directed to call the 1/4th staff of their branches or staff as per the requirement of work w.e.f. 01.09.2020 to 30.09.2020 in their respective branches. All the officials are directed to perform their duties subject to strict observance of the conditions qua Covid-19 prevention guidelines of social distancing and Aarogya Setu App etc.

NOTE :

1. All those officials who are not required to report for duty on any given day, would not leave the station under any circumstances without the approval of competent authority. They would always be available on call and would be deemed to be on duty, their concerned Presiding Officers/Branch Incharges may call upon them to report for duty as and when required.
2. If any official does not report for duty on any given day despite the direction of his/ her Concerned Presiding Officer/Branch Incharge, then he/she has to submit the leave for that period mentioning the reason for the same.
3. All the Branch Incharges are responsible for the smooth functioning of their branches.
