ORDER

In pursuance of the directions of the Hon'ble State Courts Management Systems Committee (SCMSC), High Court of Delhi in its Minutes dated 04.02.2020, in partial modification of earlier order no. Judl.II/F.75/South/Saket/2020/170-186 dated 06.01.2020, it is ordered that only those cases relating to Commercial disputes under the Commercial Courts Act, 2015 pending in the court of undersigned and in the courts of Additional District Judges, South District, which are instituted on or after 03.05.2018 shall be transferred to the court of District Judges (Commercial Court).

Further, cases instituted prior to 03.05.2018 which are pending in the court of District Judges (Commercial Court) are hereby transferred to the courts from where the said cases were received in the court of District Judges (Commercial Court).

The transferor court shall send the files / records / proceedings to the transferee court with instructions to the parties to appear before the transferee court on the date fixed. The transferor court shall also display the name of the transferee court on the notice board of their respective courts.

Ahlmads/Asstt. Ahlmad of the transferor courts are further directed to provide the lists of transferred cases to the In-charge, Computer Branch well in time for transfer of cases in CIS server.

A copy of the order be pasted on the Notice Board of District Courts Complex and be uploaded on the website of District Courts for the convenience of Lawyers and Litigants.
