That in case of fresh arrest and remand of the accused in case of special enactment like Protection of Child Rights Act, 2005, Protection of Children from Sexual Offences Act, 2012, Narcotics Drugs and Psychotropic Substances Act, 1985, and Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, Prevention of Money Laundering Act, the first appearance of accused on arrest may be made before the Duty MM. However, production of the accused for the first and subsequent remands or where the final report/Charge sheet is yet to be filed by the Investigating Authority, the accused/UTP shall be produced before the Ld. ASJs on duty as mentioned hereinabove

All the urgent applications in the pending matters will be dealt by the concerned court. Reader of the court will take necessary action in respect of video conferencing and will assist the Judicial officer during hearing. In-charge filing section will co-ordinate accordingly with the reader of the court.

The Judicial Officers shall remain available at their residence and would not leave the station under any circumstances to deal with all the above said matters of urgent nature.

Duly singed orders/proceedings sheets should get uploaded on the website. The copy of order be also made available on the email of the Ld. Counsel if requested and the email address is made available.

The Judicial Officers on duty may conduct hearings preferably through Video Conferencing, using CISCO WEBEX, to reduce congestion in Court building. And where the hearings are to be done inside the Court Room, the Judicial Officers on duty shall ensure strict adherence to the norms of social distancing.

All the courts shall also take up the matters ready for final arguments, while giving preference to more than 10 years old cases and cases where the accused is in Judicial Custody. MM (Mahila Courts) shall take up matters in which interim urgent relief has been sought under the Protection of Women from Domestic Violence Act, 1985. Rent Controllers/Addl. Rent Controller shall take up matters in which application seeking leave to contest/defend is pending disposal in the cases filed on the ground of bonafide requirement. All such matters shall be taken up through videoconferencing only. The counsel for both sides may be impressed upon to send brief written submissions through email.

In case any Judicial Officer wants to pronounce judgment in the physical presence of the parties, all the necessary precautions be taken to maintain social-distancing.

Filing of fresh matters of extreme urgency and urgent in nature shall be filed as per the advisory given in the Office Order No. Judl./Circular/F.43/SE/Saket/2020/4628-4685 dated 22.04.2020.
