ORDER NO. 21 Dated 15.07.2020

Pursuant to Order of Hon'ble High Court of Delhi bearing No. 24/DHC/2020 dated 13.07.2020 and in continuation to this Office Order No. 20 dated 30.06.2020, the functioning of the Courts of South-East District shall continue to remain suspended till 31.07.2020 on account of Covid 19 lockdown on same terms. All the Courts shall take up urgent cases (*except where evidence is to be recorded*) in terms of Delhi High Court Order No. 16/DHC/2020 dated 13.06.2020.


As per directions of Hon'ble High Court of Delhi, physical filing shall be allowed w.e.f. 16.07.2020 for non-urgent/ordinary matters with the stipulation that all such matters shall be taken up for hearing only after the normal functioning of the courts is resumed.

The following Judicial Officers of South-East District, Saket Courts Complex, New Delhi are hereby authorized to hear and dispose of fresh bail/urgent Criminal Applications in the cases where charge sheet has not been filed and also in case of fresh arrest and remand of the accused in case of special enactment like Protection of Child Rights Act, 2005, Protection of Children from Sexual Offences Act, 2012, Narcotics Drugs and Psychotropic Substances Act, 1985, and Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, Prevention of Money Laundering Act, the first appearance of accused on arrest may be made before the Duty MM. However, production of the accused for the first and subsequent remands or where the final report/Charge sheet is yet to be filed by the Investigating Authority, the accused/UTP shall be produced before the Ld. ASJs/ADJs on duty w.e.f. 16.07.2020 to 31.07.2020:
