





Terms and conditions for auction of One condemned Vehicle bearing No. DL-1CJ4605 (Maruti Esteem) are as under :

1. The bidder have to deposit Rs. 15,000/- each as security money with the Administrative Officer (Judicial), Caretaking Branch, Room No. 204, 2nd floor, Saket Courts Complex, New Delhi before 01:00 pm on the day of the bid.
2. The reserve price of the bid of the above condemned car shall be Rs. 20,000/-.
3. The purchaser should submit his/her address proof to this office at the time of auction.
4. The purchaser of these vehicle has to give an affidavit that he will scrap the vehicle in time bound period i.e. within one month and intimate the same to this office and he will no sell it further to anybody.
5. Vehicle will be available and sold on " AS IS WHERE IS" basis.
6. Successful bidder will be allowed to remove the vehicle only after submitting affidavit as required and after permission from the Ld. Pr. District and Sessions Judge (South), Saket Courts.
7. Higher bidders will deposit the entire amount of bid after completion of the auction process on the same day.
8. Unsuccessful bidder shall be returned earnest money at closure of auction process.
9. It is mandatory for the successful bidders of the vehicles to surrender the engraved portion of the chasis for the cancellation of registration certificate of these vehicles.
10. If successful bidder fails to deposit the full and final bid amount of the condemned vehicles, the security amount will be forfeited.
