

Note :-

Whenever any Judicial Officer mentioned in column no. (2) is on leave or is not available due to any reason, his/her work shall be looked after by the link Judicial Officer mentioned in column no. (4) and (5). In case all the judicial Officers of the same row are on leave or not available due to any reason the Judicial Officer whose name is mentioned immediately below the name of the Judicial Officer mentioned in column no. (5) shall act as link Judicial Officer for such duration and so on and so forth for disposal of the bail/urgent applications of the respective police station.

Production of the accused for the first and subsequent remands or where the final report/Charge Sheet is yet to be filed by the Investigating Authority in case of special enactments as mentioned above shall be done before concerned courts as per Jurisdiction. Special remand for Sessions is for Jail No. 4 & 5 shall also be heard by the respective courts as per Jurisdiction.


