Subject: Regarding Transportation reimbursement by the Department of Women and Child development, GNCTD for witness in POCSO cases in Vulnerable Witness Deposition Complexes

This is with reference to meeting dated 22.09.2022 convened by Hon'ble Juvenile Justice Committee, High Court of Delhi with respect to all the necessary facilities for Vulnerable Witness Deposition Complexes (VWDCs) in all POCSO Courts, which is reproduced as under:


"Principal District & Session Judges in Delhi shall ensure that all necessary facilities including transportation, support persons and attendant staff are provided to all VWDCs in their respective districts. In case transport facilities are not available, the car can be hired and expenses of it will be borne by the DWCD."

In this regard, the procedure for reimbursement shall be as under:

- The support person on the directions of the court shall facilitate the witness & accompany them to the court using transportation facility of cabs/taxi etc. The bills are to be submitted by the support persons of the concerned District Child Protection Officers/ District Child Protection Units.
- District Child Protection Officers will process these bills for reimbursement and shall be responsible for making reimbursement within a week time through PFMS. In case witness/victim commutes on his/her own, he/she shall be entitled to claim reimbursement from the District Child Protection Unit on the basis of actual bills. In case no bill is produced, then such payment must not exceed Rs. 500/-
- In this regard, all District Child Protection Officers and Joint Signatory of DCPU are hereby directed to reimburse the payment to the court concerned/support person within a week time. All District Child Protection Officers are further directed to send a fortnightly report regarding the same.
