CIRCULAR

The Hon'ble Supreme Court of India, vide Civil Appeal No 5305/2022 in the case title State Bank of India and Another Vs. Ajay Kumar Sood is pleased to direct that

All judicial institutions must ensure that the judgments and orders being published by them do not carry improperly placed watermarks as they end up making the documents inaccessible for persons with visual disability who use screen readers to access them. <u>On the same note,</u> <u>courts and tribunals must also ensure that the version of the judgments</u> <u>and orders uploaded is accessible and signed using digital signatures</u>.

It is worth to mention here that in this context, two circulars bearing numbers 4586-5086/Comp./Dig.Sign./2018 dated 11.01.2018 and 11102-11227/Comp./Dig.Sign./2018 dated 31.01.2018 were also issued earlier by Mr. Talwant Singh, the then Ld. D&SJ (Hqs) to all Ld. Judicial Officers, Delhi District Courts, conveying thereby the direction of Hon'ble IT Committee, DHC for appending digital signature on all the Judgments.

Further, it has come to the notice of undersigned that some of Ld. Judicial Officers are not complying with the direction scrupulously.

Therefore, in order to ensure compliance of above directions, it is impressed upon to all Ld. Judicial Officers to ensure that no judgments/orders be uploaded on CIS without appending their Digital Signature Certificates thereon.
