- 1. Should have membership of Saket Bar Association (SBA) for at least one year, as on 31.07.2024 (in terms of clause 10 of Memorandum of Association & Constitution
- 2. Should have no arrears of subscription to SBA as on 31.07.2024.
- 3. Should be bonafide practicing lawyer in terms of following:-

a) Designated Senior Advocates.

b) Advocates who have a standing of over Twenty Five (25) years.

c) Former Judicial Officers.

- d) Advocates who have at least Twelve (12) appearances before Courts including Supreme Court, Tribunals and Arbitration Tribunals in a span of a year.
- e) Law Researchers who are engaged with Hon'ble High Court of Delhi.

f) Partner or an Associate of a registered Law Firm.

None of the aforesaid advocates would be considered bonafide advocates if they have not cleared the All India Bar Examination in the event the said condition had been stipulated prior to their enrollment.

INSTRUCTIONS FOR FILING OF OPTION/ DECLARATION FORM

- Each Declaration/ Option Form shall be numbered, on the top left side of the Form. 1.
- All the entries in the Declaration/ Option Form shall be clearly filled in with signature 2. of member in blue colour ink. Incomplete form shall not be accepted/ summarily rejected.
- The photograph should be original recent photograph of the member in full robes 3. and not a computerized copy. Computerized photographs shall not be accepted and Declaration/ Option Form shall be summarily rejected. The photograph should be signed by the Member (preferably with the CD Marker/ indelible ink) in such a manner that half of the signature appears in the form and the other half appears in the photograph.
- 4. Attach a copy of ID Card of SBA.
- Attach a copy of ID Card of BCD. 5.
- Attach supporting documents in support of their submission at item no. 10 of 6. declaration/ option form.
- Advocates claiming voting rights on the basis of appearances shall furnish the 7. copies of the Twelve (12) order sheets of different cases & / or court containing their names either as a lead counsel or as an assisting counsel on or before 31st July, 2024.
- Advocates claiming voting rights on the basis of being a Partner or an Associate of 8. a Law Firm shall furnish, prior to 31st July, 2024 a certificate from the Equity Partner of the Law Firm along with proof of payment of professional remuneration for at least six months
