Sub: Extention of time for removing objections of Declaration Forms

Committee considers the request of Hony. Secretary, Saket Bar Association (SBA) along with the representation of members of Bar, on the subject mentioned herein above. Hony. Secretary in his letter has submitted that there are objections in approximately 1500 Declaration Forms and most of the objections are of AIB Examination Certificate and that the AIB Examination Certificates are being issued by Bar Council of Delhi or the Bar Council of India. Their members are facing difficulties in securing certificates in stipulated time.

Considering practical difficulties being observed by members of SBA, this committee unanimously resolves to extend the date for filing of response to the objections raised in the declaration forms, till 09.10.2024, 4:00 PM. This committee simultaneously publishes list of remaining members of Bar who have yet not submitted response to objections in their declaration forms (List A) and also the list of members who have submitted the response, however objection(s) is/ are still persists (List B).

Both the lists i.e. Lists (A) & (B) be communicated to Saket Bar Association through it's President/Hony. Secretary for wide publicity amongst it's members. Same be uploaded on the website of Delhi District Court [delhidistrictcourts.nic.in](http://delhidistrictcourts.nic.in) and on the websites of South & South East districts [districts.ecourts.gov.in/southdelhi](http://districts.ecourts.gov.in/southdelhi) & [districts.ecourts.gov.in/southeastdelhi](http://districts.ecourts.gov.in/southeastdelhi) in PDF read only format and be displayed on the notice board(s) of this court complex for information of all concerned.

In Cons. :

I) Letter dated 26.09.2024 received from Sh. Amit Kumar, Advocate for extensive scrutiny of order sheets of Declaration Forms.

The office has placed before the Committee representation submitted by Sh. Amit Kumar, Advocate. In his representation Amit Kumar, Advocate has submitted that many fake declarations have been filed by some candidates contesting in the coming election of Saket Bar Association using forged/ edited order sheets to claim themselves as bonafide advocates to have voting rights. Applicant with his representation enclosed list of around five hundred (500) advocates whose declaration forms he objected to.

Matter is discussed in details. It is observed that the applicant herein didn't disclose his identity like his BCD Enrollment, Membership of SBA, Address etc. except that he wrote "advocate" against his name & signature, even he didn't disclose source of his objections. It is observed that it would not be feasible to rescrutinise declaration forms of around five hundred (500) advocates having twelve (12) or more copies of order sheets in each declaration form, within this short term when Hon'ble High Court is pressing high to issue proximity cards in a specific time period. Simultaneously, notice dated 24.09.2024 which published lists of tentative voters required the response in a prescribed format. The said format itself mentioned that "objections against declaration of other Member would be summarily rejected if an advance copy of the objections is not served upon that party and acknowledge is not taken on this form itself". The applicant herein didn't follow the instructions of notice.

In view of above, this committee unanimously resolves to file the representation, hence no action is called for.
