CIRCULAR

Sub:-Ensuring operation of Thin Client Machine and Digital Display boards / Console box.

In terms of the directions received from Ld. Chairman, Centralized Computer Committee with regard to filing of fresh status report qua functionality of Thin Client Machines and Display boards before the bench of Hon'ble Chief Justice, High Court of Delhi, all the Ld. Judicial Officers of South and South-East District are once again informed that matter with regard to usage / operation of Thin Client Machine and Digital Display boards/ console box is of prime importance as non-usage of the same cause inconvenience to the Lawyers and Litigants as they are not able to view the realtime case status / item no. on the TFT Screen / Display board installed inside / outside of court room. Further, it is informed that this matter is being regularly monitored by Hon'ble High Court of Delhi and Ld. Chairman, Centralized Computer Committee (Hqs).

Earlier also directions for ensuring operation of Thin Client Machines and Digital Display boards / console box have already been issued vide Circular no. 34614-34754 dated 09.10.2024 and 9222-9352 Dated 04.03.2024 issued by the undersigned.

In view of the fresh directions received as mentioned above, all the Ld. Judicial Officers of South and South-East District are once again requested to issue following directions to their Readers / concerned officials and to ensure its necessary compliance:-

- To ensure operation of console box provided in each court room of the main court building in synchronization with the case item no. of the causelist being called(by pressing F5 button) for displaying the information on the Digital display board installed outside the court room and large Digital display board installed at Facilitation Center and Lawyers Block.
- To ensure operation of Thin Client Machine installed in all the courts for display of live case status and item no. of the causelist presently heard in the court on the TFT Screen installed inside / outside of the court room.

In addition to above, Branch In-Charge, Facilitation Centre / e-Sewa kendra and Assistant Engineer (Electrical) PWD to ensure working of 46" LED display screen installed outside Facilitation center and Lawyers Block respectively for display of cause list of Hon'ble Supreme Court of India and Hon'ble High Court of Delhi during office hours.

Non compliance of the aforesaid directions shall be viewed seriously and if concerned staff official is found fail to operate the Thin Client Machine disciplinary action shall be taken against the erring staff official.

This issues with the prior approval of Ld. Principal district & Sessions Judge, South District and Ld. Principal district & Sessions Judge, South-East District.
