Presiding Officer of Evening Court No. 2 (South East) District is on leave or not available otherwise, the Ld. Presiding Officer of Evening Court No. 1 (South East) District is on leave or not available otherwise, the Ld. Presiding Officer of Evening Court No. 1 (South East) Shall deal with the work of both Evening Courts. In case both the Ld. Judicial Officers of Evening Court No. 1 & 2 (South East) District are not available, the Ld. Duty Judicial Magistrate of the day, South-East District shall deal with the work of both Evening Courts, South East District for that day.
- (iv) It is further, impressed upon the Ld. Judicial officers holding the Evening Courts that he/she shall hold the Court in the Room specifically earmarked for the said purpose and not in their own regular Court Room.
