ORDER

It is brought to my notice that two Judicial Officers namely **Smt. Rachna Arora**, Addl. District & Sessions Judge Court No. 3, Bareilly and **Sri Mradanshu Kumar**, Addl. Civil Judge (Sr. Div.) Court No. 1, Bareilly are reported to be Corona positive and many other Judicial Officers are already reported Corona positive earlier.

It is also brought to my notice that 08 employees of District Court, Bareilly namely 1-**Km. Sonam**, 2-**Sri Prabhat Sharma**, 3-**Sri Yogesh**, 4-**Shishu Pal**, 5-**Sri Arjun Chaudhry**, 6-**Sri Shailendra Singh**, 7-**Sri Balveer Singh** and **8-Sri Danish Ali** have been found Corona positive and many other employees' reports are awaited.

In the above circumstances it would be essential to close the Court campus for 48 hours i.e. 22.04.2021 and 23.04.2021 for complete sanitization of Court premises. So that fervent and continuous sanitization of the Court premises be done. Letter be written to the District Magistrate and Chief Medical Officer, Bareilly for the purpose aforesaid. Officer-incharge, Nazarat/ Chairperson, Covid-19 Committee, District Court, Bareilly shall take personal interest in sanitization work and to furnish their report.

The general dates for the cases fixed on 22.04.2021 and 23.04.2021 will be fixed on **20.05.2021 and 21.05.2021** respectively. However, it shall be open for concerned Presiding officer to fix any other date for any particular case like in which directions have been given by the Hon'ble High Court and Apex Court if situation so warrants.

The urgent matter fixed for 22.04.2021 and 23.04.2021 shall be taken up on **27.04.2021** and **28.04.2021** respectively.

The outlying Courts shall remain opened on 22.04.2021 and 23.04.2021.

In pursuance of directions of Hon'ble High Court laid down vide letter No. 1941/LXXXVII-CPC/e-Courts/dated 05.04.2021 after discussion with President of District Bar Association, Bareilly it has been decided that the District Court shall remain closed for vigorous sanitization of Courts/Offices and whole Court compound on **22.04.2021 and 23.04.2021.**

The Chief Judicial Magistrate, Bareilly is directed to make necessary arrangement for remand work similar as routine holidays.

The daily statement/necessary administrative work shall be performed as per requirement at the Camp office.

Copy of this order be sent to Bar Association, Bareilly for information and necessary action.

Copy of this order be sent to the daily news papers for publication and a copy of this order be uploaded on the website of District Court, Bareilly.

All concerned be informed accordingly and a copy of this order be also pasted on notice board of Court campus.
