In the present prevailing circumstances and in order to ensure equal distribution of work amongst all the officers, the Presiding officer of the Court of Additional District & Sessions Judge Court No. 6/Spl. Judge Anti Corruption (VB-UPSEB), Bareilly Smt. Pratibha Saxena-II, is designated as a Special Judge for try the cases instituted under the N.D.P.S. Act.
