The District & Sessions Court, Gwalior invites sealed tender for Mechanised cleaning service/ Liftmen services/ Maintenance of garden in complete new court building premises and service block in the New court Building, Gwalior (M.P.) from reputed, registered, bonafide, experienced and eligible firms/contractors, who have executed similar nature of work in Government Ministries/Departments, Semi-government organizations including Public Sector Undertakings and satisfying all other terms and conditions of this tender document.

### **1. Instructions to the Tenderers:**

Tender will be invited in sealed envelope consisting of Techno-commercial & Price Bid. The bid will be made and put in the sealed single envelope containing the title "TENDER FOR MECHANISED CLEANING SERVICE/ LIFTMEN SERVICES/ MAINTENANCE OF GARDEN IN COMPLETE COURT BUILDING PREMISES IN THE NEW DISTRICT COURT BUILDING AND SERVICE BLOCK GWALIOR (M.P.)" and addressed to the Principal District & Sessions Judge, Gwalior and the Bid will be submitted to the Principal District & Sessions Judge, Gwalior latest by 05-04-2024 The Tender will be opened on 06-04-2024.

Tender relates to 'Mechanised cleaning service, Liftmen services, Maintenance of garden in complete building premises and Service Block' in the New District Court Building Gwalior (M.P.). The Tenderer shall clearly specify what items/Manpower/Machines/Services will not be covered under the operation services. All the remaining items/services shall be treated as covered under the operation services.



## **2. Period of Contract:**

The contract shall be initially for the period of **one year** from the date of agreement which can be extended further on mutual agreement subject to satisfactory performance of the contractor and will also depend upon the price trend for the services/products in the market on the date of extension.

## **3. Scope of Work :**

3.1 The place of performance will be the New District Court Building, Gwalior and whole Campus. Tender relates to Mechanised cleaning service, Liftmen services, Maintenance of garden in the new Court Building, Gwalior.

3.2 It will be duty of the Contractor/Service Provider to have the credentials of the Service Persons/Operator duly verified certified and person engaged for services for cleanliness, Liftmen services, Maintenance of garden in shall bear clean and proper dress and photo ID to be provided by the contractor/service provider. The contractor will have to abide with Labour Laws including Payment of Wages/Minimum Wages Act, Contract Regulation Act, Factories Act and other laws notification made applicable time to time.

3.3 Adequate number of the cleaning machines with qualified operators shall be deployed for Mechanized Cleaning for the places where Mechanized Cleaning is feasible and adequate number of service persons/manpower shall be employed for cleaning of the places where Mechanized Cleaning is not feasible/possible.

3.4 The Contractor shall provide trained supervisor/supervisors to ensure proper maintenance and management of persons/manpower and the machines etc. With tender, the bidder shall also submit a list of persons, Instruments and Machines, who/which shall be engaged/used for carrying out works under this tender timely and upto the mark.

3.5 The Contractor shall arrange wet and dry cleaning of all the areas of complete Court Building and Service Building everyday. It shall be duty of the

Contractor to dispose the garbage as per the rules. The wet cleaning shall include the cleaning by use of proper soap, phenyl and other cleaning chemicals of standard and reputed make. The instructions of the Principal District & Sessions Judge, Gwalior in this regard shall be final and binding on the contractor.

3.6 The Mechanized Cleaning Services shall include cleaning of all the court rooms, chambers, officers rooms, barandas, adjoining places, toilets, urinals, porch, water coolers, garages and the campus of District Court, Gwalior including of Service Building.

3.7 The vendor shall depute one sweeper/cleaner at every set of Gents and Ladies Toilets through out the working hours on the any working day, These sweepers/cleaners shall ensure regular cleaning and sanitation two or three times of the day in public toilets.

3.8 Place of performance for cleanliness shall include the judicial, lockups, corridors, employee's common room, petition writer room, common toilets in campus and service building in addition to the Main Court Building.

3.9 First shift cleaning shall be completed till or before 9.00 AM and thereafter cleaning shall done within every 3-4 hour on as per Direction of authorities.

3.10 The cleaning work of any particular day shall, under all circumstances, be finished by the Contractor on the same day. If the work is not finished on the same day, a penalty of Rs. 1000/- per day shall be leviable from the amount payable to the Contractor. If any machine remains out of order for a continuous period of more than three days without replacement/repair or the contracted Number of the Operator/Services Persons/sweepers/gardner of the vendor remains absent for three days continuously, an amount of Rs. 500/- per day per machine/per person shall be deducted from the amount payable to the Contractor.

3.11 It shall be duty of the Contractor/Supervisor/Authorised sweeper/cleaners to ensure safety of all the equipments, sanitary, fittings, pipes, pots exhaust fan etc. installed in the public toilets. The Supervisor/authorised

sweeper/cleaner shall lock and handover the keys to District Nazir after the working hours on every working day when court is open. Any loss, for whatever reason, shall immediately be reported to the District Nazir failing which, the loss shall be attributable to the negligence of employees of the Contractor.

3.12 Sufficient stock of consumables like soap, phenyl, room freshner, brush, utensils, floor wiper, etc. for a month should be maintained.

3.13 The cleaning work shall start functioning within 03 days of the receipt of work order.

3.14 The maintenance of Garden shall include maintenance of grass carpets, flower-bed, small and bigger plant and the flower pots already in existence in New District Court Campus. It shall also include maintenance of water-fountain. The vendor/contractor shall arrange plants, fertilizers, seeds, clay grass, pots, utensils, instruments and machines required for maintenance and beautification of the garden.

3.15 Adequate number of trained Lift-men shall be provided by the contractor/service provider for five floors & eight lifts for proper operation of lift. Lift man remain present at all time during 10:00 am to 07:00 pm. On all working days to operate each Lift installed in Main Court Building & Service block also whenever required even in non-working days. Liftman will ensure cleanliness of lift and keep the whole functioning of lift as per technical specification.

3.16 A Surprise check shall be conducted by the authorities nominated by the Principal District Judge to ascertain the performance of the service persons/operators/ cleaners/ sweepers/ gardners and services provided by them. In case of absence, misconduct, misbehaviour and irregularities found action shall be taken.

3.17 The agency applying should possess valid income tax PAN no., GST no., Labour license no. The agency should have minimum experience of three years providing cleaning Services.

3.18 The successful Tenderer will be required to furnish Earnest Money Deposit amounting to Rs. 500000/- within 10(ten) days from the date of

acceptance of tender. The Earnest Money shall be in the form of FDR through any nationalized bank in favour of the Principal District Judge, Gwalior or unconditional Bank Guarantee of any Nationalized Bank of equal amount. The Earnest Money Deposit/Security deposit Money will be refundable only after the expiry of the contract period. The Earnest Money Deposit will be forfeited if during the period of contract the services are found to be unsatisfactory in any respect. Premature withdrawal of the Tender by the Tenderer shall make him liable for forfeiture of the earnest money/ Security Deposit.

3.19 Principal District Judge, Gwalior reserves the right to blacklist/Termination of contract on unsatisfactory services/breach of any condition of contract/Corruption/Fraud/Criminal Record. The decision of the Principal District Judge, Gwalior shall be final and binding on the firm/agency.

3.20 Any other work of similar nature assigned by the Principal District & Sessions Judge, Gwalior will be binding on the Contractor.
