

Pursuant to the Office Order No. 159/RG/DHC/2020 dated 25.03.2020 vide endorsement No. 160-193/RG/DHC/2020 dated 25.03.2020 and in continuation of Notification number 373/Estt.E-1/DHC dated 23.03.2020 vide Endorsement No. 7657-89/Estt.E-1/DJC dated 23.03.2020 issued by High Court of Delhi, New Delhi and taking note of Government of India, whereby a nationwide lockdown has been declared for a period of 21 days w.e.f. 25.03.2020, the functioning of the District Courts shall now remain suspended till **15.04.2020** or until further orders.
