#### <u>ORDER</u>

Vide Office Order No. 896/RG/DHC/2021 dated 30.12.2021 with Endst. No. 897-938/RG/DHC/2021 dated 30.12.2021 regarding revised system of hearing of cases in Delhi High Court and Delhi District Courts, Hon'ble High Court of Delhi, New Delhi has been pleased to order that the District Courts in Delhi shall, with effect from 03.01.2022, hold courts through virtual mode only, till 15.01.2022. The video conferencing links of the courts shall be made available on the website/cause-list(s).

All the stakeholders including court staff, required to come to the Courts, shall get themselves fully vaccinated and shall strictly adhere to the norms of social distancing and Covid-19 protocols, guidelines, directions, etc. issued by the Government of India, Government of NCT of Delhi and Hon'ble High Court of Delhi from time to time.

1) The President and Hony. Secretary of the Bar Association may issue necessary directions in order to ensure that there is no crowding in the Court Complex including the lawyers chambers.

2) All the UTPs be produced through virtual mode till 15.01.2022 or till further orders.

**3)** The daily order(s) of Judicial proceedings etc. shall be the responsibility of the concerned court staff to be uploaded on CIS, as per the applicable Rules.

4) The cases in which the dasti copy is ordered by the Judicial Officer(s), digitally signed copy of same be sent to the concerned advocate(s)/litigant(s) by the Reader of the Court on their respective e-mail(s) and same would be treated as dasti copy.

**5)** The Judicial Officer(s) presiding over the Designated Courts/Special Courts i.e. POCSO, SC/ST, TADA, POTA MACOCA etc. shall be continue to deal with the remand work etc. of their concerned court by virtual mode.

6) Due to acute shortage of staff, no official is permitted to work from home. All the staff members posted in court(s) or branch(s) are directed to attend the office on regular basis.

7) In the absence of undersigned, Sh. Harish Dudani, District Judge (Commercial Court) and in his absence Sh. Pitamber Dutt, Addl. Sessions Judge-02 (SC/ST) & H. R. Dwarka Courts shall be the Officiating Principal District & Sessions Judge.

The above-said directions shall remain in-force till 15.01.2022 or till further orders.
