This is in continuation of office letter No. 26118-26236/PD&SJ/NK/DWK/2022 dated

01.01.2022 issued in pursuant to the Office Order No. 896/RG/DHC/2021 dated 30.12.2021 vide

endorsement No. 897-938/RG/DHC/2021 dated 30.12.2021 issued by Hon'ble High Court of Delhi,

New Delhi, District Courts to hold the courts through virtual mode only w.e.f. 03.01.2022 till

15.01.2022 or until further.

In view of the spike in Omicron infection, Presiding Officer(s) of each of the Courts and the

Officer In-charge(s) of the concerned Branch(s) in South West District, Dwarka Courts can take a

call as regards the numbers of the officials to be called to the Court building for physical duty. The

Judicial Officers may exempt staff under their control from attending the court premises physically

and those exempted from physical visit to the court shall work from home.

The entire record of exemption from physical duty shall be maintained in the

Court(s)/Branch(s) and duly authenticated by the Presiding Officer/Officer In-charge(s). It shall,

however, be ensured that work does not suffer at any given time, at least half of the staff is available

in concerned Branch(s).

Any official who gets infected or in case somebody from his/her family gets infected, shall

have to seek leave as per the prevailing Circular(s)/Rules.

On account of acute shortage, substitute staff can not be provided. The Officer In-charge

(Admn.) through the Branch In-charge (Admn.) shall provide substitute stenographer(s) if and when

available.

In a situation where all Court official posted in a Court are not able to perform physical duty

and the Court files can not be made available to the Presiding Officer, Officer may on his own

adjourn *enbloc*, cases listed for that day, recording the reason.
