All the members of DCBA desirous of being figured in the said "Voter List" are hereby called upon to furnish duly filled "**Declaration Form**" as per the prescribed format, which has been displayed on the notice board (Annexure -'A'). A printed format of the 'Declaration Form' can be obtained from the Facilitation Centre, Dwarka Courts also.

The members of DCBA are required to submit the duly filled declaration forms (as per prescribed format), within a period of **12 working days** starting from 10.12.2021 and ending on 24.12.2021 (from 11: 00 am till 4:00 pm).

The members are required to paste the latest (most recent) passport size photograph on the declaration forms. The declaration forms shall be submitted by the members of the Bar, **in person only** (i.e. not through any representative), alongwith a Certificate from DCBA to the effect that the requisite dues (i.e. upto 31-12-2021) have already been paid by them.

**Note:**

- a) **The last date for submission of declaration forms (i.e 24/12/2021) is final and shall not be extended. Any request for late acceptance of the declaration form beyond 24/12/2021 (04:00pm) shall not be entertained, in any case.**
- b) **Keeping in view the COVID-19 protocol and to avoid last minute rush, the members are advised to submit the declaration forms at an early date.**
